<u>Water Supply</u>: Following investigation it was confirmed that the water supply to the RNLI building is on the same supply as the public toilets, following discussion it was agreed the supply should be metered separately. Invoice 7056 7644 63 has been received for water services 20 December 2016 to 9 March 2017 of £5,224.29 South West Water has been advised this invoice is in dispute and payment will be withheld for the time being. Following investigation there are no leaks at the public toilets however it is possible that there is a leak on the supply further on from the public toilets going to the RNLI building who will investigate this as soon as possible. Widemouth Café has its own metered water supply. Two estimates were received for the installation of an unvented hot water cylinder and an inline instantaneous water heater for hot showers outside the building, following discussion it was agreed to obtain estimates from a second contractor.

- <u>Electric supply</u>: Awaiting response from Cornwall Council to separate the electric supply currently shared between the public toilets, RNLI building and parking meters.
- (c) Re-painting the Building: A painting party of volunteers is to be arranged as soon as the paint has been received and the weather is favourable.
