

It's not perfect but we hope you will find it of lasting use and even persuade you to participate more fully in these times of change when we are about to lose one elected layer of governance. 



The lower (diary) page is designed to be informative and attractive and summarises the content of the page above.

The upper page therefore comprises:

"What this means and why" enlarging on how the policy has been derived and its intended effects:

the "Priority Rating" derived from the degree of support for each proposition in the Survey and the star rating achieved at the Prioritisation Event in December 2007. It should be appreciated that some elements will be easier to achieve than others and will therefore be fulfilled earlier than the rating might suggest. The rating should be regarded more as an indication of the amount of effort which will Recreation & Leisure Weeks 27-34 be applied to each element;

the "Sustainability Ratings" as defined by the Government and provided by NCDC. SOME OF THE MAIN CONCERNS.

There is a growing awareness that throwing money at something does not always provide a solution which we will later be able to support. Coupled with "Green" concerns, this forms the basis of the Sustainability Ratings in our Plan. To some, the following notes may be self-evident but nevertheless it may help to define objectives for the future invigoration of our Parish.

Affordable Housing - A better and more wide-ranging supply of affordable housing to rent and for sale will have a positive effect on other areas of local life. Young people are more likely to stay in the area if they can afford to live locally.

Quality Jobs - A good supply of easily accessible better paid jobs will encourage young people to stay in the district. .


Waste reduction and recycling - A high participation rate also indicates a measure of community pride and engagement.

WHAT THIS MEANS AND WHY. At the prioritisation event in December 2007 the vicinity of Bangors was identified by residents as the natural centre of Poundstock. "Poundstock" as a village consists of three components: Bangors, Treskinnick and, to a lesser extent, the Parish church vicinity, No one wants to see wholesale development merging these three together but there may be ways in which some housing development linked with subtle land use changes, could create a greater sense of identity. We will never get our school back, but we must build on what we have and the immediate local community will be directly involved in any approach initiated by the Parish Council

Priority rating- Highest

Sustainability rating: uncertain pending outcome. Enormous potential to tick "Building Sustainable Communities" "Buildings, Planning & Land Use" "Managing the Environment & Resources" "A Sustainable Economy" "Housing" "Social Equity & Opportunity" but will need extensive public consultation.

WHAT THIS MEANS AND WHY: From the Questionnaire, it was revealed that there is overwhelming support for provision of affordable housing to people with local connections. 54 respondents, either themselves or their immediate family, had need of affordable housing. Whatever overall policy might be in place at any one time, commercial factors make it unlikely that this demand will be satisfied in the normal course of redeveloping existing residential sites. Conversely, any suitable land already considered to have housing potential carries too high a value to permit a meaningful contribution to be made- i.e. for a house to be affordable, the site it's to be built on must be valued at less than £50,000. The Plan recognises this and, whilst including a policy statement, will actively resist any attempt to circumvent the aim to serve the families of people already established in Poundstock.






Dear Friends

Road safety policy 5. The county council will be pressed to investigate the feasibility and cost of providing footways on the A39 between Bangors and Treskinnick cross and from Fowlers Caravan Park to Widemouth Manor.

Recreation & leisure policy 1. The parish council will use every endeavour to achieve the construction of a footway/cyclepath parallel to marine drive because of its potential contribution to road safety, enjoyment of the unique landscape and its value for the tourist trade

Recreation & leisure policy 4. The parish council will actively support and promote a wide range of outdoor & indoor activities in the light of comments received.

Recreation & leisure policy 7. In order to provide a sound financial foundation to sustain the parish hall, the implications of seeking of a drinks license will be investigated.

Information policy 4. New notice boards will be provided, subject to finance, at all locations which can easily be accessed by the majority of parishioners.

Information policy 5. The parish council will endeavour to ensure that notice boards carry all information which is of relevance to the community.

Information policy 7. People will be encouraged to make fuller use of the recycling facility at Widemouth bay's public car park

Social equity policy 3. The parish council values the contribution to the community made by the Poundstock Packet magazine. In appreciation of its good work, it will make an annual donation for its support during the lifetime of this plan.

Medium priority

The built environment policy 3 the parish council will seek a response from the appropriate source on the feasibility of connecting Poundstock homes to the national gas supply and will investigate & publicise information on alternative renewable energy options.

Recreation & leisure policy 8. Opportunities to socialise in environments appropriate to the occasion will be encouraged. Health policy 1. Contact will be established with the appropriate authority to establish if blood pressure tests can be

transferred from the health clinic to the premises at the bowling green.

Business policy 1. Dialogue will be opened with local businesses to establish how they would like to promote their operations through the auspices of the parish council and identify availability of local staff

Road safety policy 4. The parish council will initiate discussions with the appropriate authorities to resolve what is identified as a major cause for concern with respect to traffic speed on the former trunk road

Recreation & leisure policy 2. The parish council will press for an early review of the outright ban of dogs on the beach in summer months and will seek further consultation.

Information policy 1. Operators of mobile shops will be encouraged to supply details of their schedules for display on village notice boards.

Information policy 2. The parish council will investigate ways of publicising public rights of way and will press ahead with a review of their current status and condition

Social equity policy 2. The issue of charitable donations will be the subject of a special report to the parish council.

Social equity policy 4: the parish council will work with the community and the appropriate authorities to investigate the support for and the setting up of a children's playgroup

The built environment policy 5 a review of the provision of dog waste bins will be undertaken and provision made following discussion with the appropriate authorities.

The built environment policy 6. A review of the provision of litter bins will be undertaken and provision made in suitable locations following discussion with the appropriate authorities

Business policy 4. The parish council will support and investigate promotion of on-line shopping through publicity of appropriate web-sites.

Information policy 3. The parish council will support but not actively promote a Poundstock website although the issue will be kept under review.


